Rights and Reproductions

The Wilmette Historical Museum seeks to balance our goal of making images of items in our historical collections available to all those who want them with the need to take into account the costs associated with obtaining, cataloging, reproducing, and preserving these images. With this in mind, WHM charges a fee for the use of our images, in some cases.

Determination of which fees apply in any given instance is at the discretion of Museum staff. Any requests outside of the definitions of “Standard Use” require special consideration regarding fees. All fees are in U.S. dollars and are charged per image, for a single use. Fees must be paid in advance before an order can be processed. *A Digital Image Request form must be completed for all requests requiring payment.*

The Wilmette Historical Museum reserves the right to deny permission to use images or to limit any requests.

Standard Use

The Wilmette Historical Museum defines “Standard Use” of its images, either personal/non-profit or commercial, as single, one-time use of an individual image. **Personal/non-profit Standard Uses** include, but are not limited to: inclusion of an image in a personal genealogy file, display at home, display at a non-profit event, publication in a scholarly article or website, or use in non-profit marketing materials. **Commercial Standard Uses** include, but are not limited to: display in a business, such as a store or restaurant, inclusion in a for-profit publication, website, or documentary, or use in marketing/advertising materials. Unique requests outside of Standard Use may require a different charge. Please contact WHM with any questions on these types of image requests.

Copyright

Many images may be recent enough to be covered by copyright law, which means that only the copyright holder – usually the person who took the photograph or otherwise created the image – can give permission to publish those images. The Museum’s transfer of a copy of an image does not in any way constitute permission to publish it either in print or online, and the Museum takes no responsibility for any legal claims arising from such publication. As the person obtaining a copy of an image from the Museum, *you are*

solely responsible for seeking and obtaining all necessary permissions from any existing copyright holders before reproducing or publishing that copy.

Credit Line

“Courtesy of the Wilmette Historical Museum” or “From the collections of the Wilmette Historical Museum”

Any image that you publish that was acquired from the Museum must be accompanied by credit to the Museum. When images are used in public displays or exhibitions, it is preferred that the credit line be accessible and near the image. In print, credit should be placed adjacent to the image. For web use, please include a link to wilmettehistory.org.

1. **To use the image copy (or copies), listed on the Digital Image Request once and only for the purpose listed in the Statement of Intended Use.** Any subsequent or different use (including subsequent editions, book club editions, different language editions, etc.) constitutes a re-use and must be applied for separately and in writing. There is a re-use fee.
2. **To credit properly: “Courtesy of the Wilmette Historical Museum” must appear** in the credit line near each image in printed works or exhibits, whether hardcopy or online, on the same page or a facing page. In films, acknowledgement must be included in the credits or sources section.
3. **To give the Museum one complimentary copy** of any published work in which the reproduced image(s) appears.
4. **Not to permit others to reproduce the image(s)** or facsimile thereof.

In authorizing the publication of the image(s), the Village does not surrender, convey or diminish its own right to publish the image(s), or to grant others permission to do so. Copyrighted material will ordinarily not be copied without the written consent of the copyright holder. The Applicant assumes all responsibility and liability for claims of infringement of copyright or any other legal claims that may arise from the copying or use made of the image(s). The Village reserves the right to limit the number of images copied or to restrict their use and, at its discretion, to charge a higher reproduction fee than specified herein to meet special circumstances. Any exceptions or additions to the above conditions must be specifically set forth in a written Rider attached hereto in order to constitute a part of the Digital Image Use Agreement.
